The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, from 1989 to 1993, you failed to maintain your attorney records in accordance with <u>R</u>. 1:21-6 and commingled personal and trust funds in your trust account. Your conduct was unethical and in violation of <u>RPC</u> 1.15.

Your conduct adversely reflected not only upon you as an attorney but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. <u>R</u>.1:20-15(f)(4).
