LETTER OF ADMONITION

## Dear Mr. Fagan:

The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was unethical. Specifically, on or about June 1996, you were retained by Christine E. Foley in connection with a personal injury matter arising out of a motor vehicle accident that occurred in May 1996. Notwithstanding your obligation to keep your client informed about the status of the matter, you failed to adequately communicate with her, in violation of RPC 1.4(a).

In addition, prior to the filing of a formal ethics complaint in this matter, you entered into an agreement in lieu of discipline with the District VB Ethics Committee, pursuant to  $\underline{R}.1:20-3(i)$ , in which you stipulated that you violated  $\underline{RPC}$  1.4(a) and agreed to comply with all conditions of the diversionary program. You

failed, however, to attend the Diversionary Legal Education course. After your attorney notified you of the next scheduled course, you took no affirmative steps to attend it. Your conduct was improper and in violation of RPC 8.1(b).

Your conduct adversely reflected not only upon you as an attorney, but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you.  $\underline{R}.1:20-15(f)(4)$ .

A permanent record of this occurrence has been filed with the Clerk of the Supreme Court and the Board's office. Should you become the subject of any further discipline, it will be taken into consideration.

The Board has also directed that the costs of the disciplinary proceedings be assessed against you. An affidavit of costs will be forwarded under separate cover.
