Dear Ms. Weinberg:

The Disciplinary Review Board has reviewed your conduct in above matter and has concluded that it was improper. the Specifically, while representing Joseph Dente in a Social Security disability matter from 2002 to 2003, you failed to advise him about important aspects of the case. After erroneously advising Dente that his claim had been denied by the Social Security Administration ("SSA"), you failed to explain your error. You also failed to notify your client that you had terminated the representation and had retained the "excess" portion of your fee while exploring avenues of appeal. Your actions in this regard violated RPC 1.4(b).

As to the charge of an excessive fee $(\underline{RPC} 1.5(a))$, the Board found no clear and convincing evidence of any impropriety. The evidence showed that your fee fell within SSA guidelines for such matters. Thus, the Board dismissed that charge.
