Dear Mr. Neary:

The Disciplinary Review Board reviewed the motion for discipline by consent (reprimand) filed by the District X Ethics Committee (DEC), pursuant to R. 1:20-10(b). Following a review of the record, the Board determined to grant the motion. In the Board's view, a reprimand is the appropriate discipline for the combination of respondent's stipulated violations of RPC 1.7(a) and (b) and RPC 1.5(b). See, e.g., In re Berkowitz, 136 N.J. 148 (1994); <u>In re Mott</u>, 186 <u>N.J.</u> 367 (2006); <u>In the Matter of Joel</u> C. Seltzer, DRB 09-009 (June 11, 2009); In the Matter of Alfred V. Gellene, DRB 09-068 (June 9, 2009); and In the Matter of David W. Boyer, DRB 07-032 (March 28, 2007).

Specifically, in 2004, respondent and her law partner, Michael G. Pellegrino, represented Plantagenet, an entity formed other clients of the law firm, to purchase tax-lien certificates. Respondent engaged in a conflict of interest when

Plantagenet purchased tax-lien certificates from other persons or entities for which the law firm prosecuted tax-lien foreclosures.

One of Plantagenet's purchases pertained to 37 Phillips Avenue, Trenton. Respondent and Pellegrino handled the tax-lien foreclosure for the certificate owner, Robert Kosch, as well as the assignment to Plantagenet. After the assignment and disbursement of funds took place, a dispute arose between Plantagenet and Kosch over the disbursements.

Plantagenet also purchased a tax lien for 302-306 Mulberry Street, Trenton, from Rina Holdings, another client of the law firm. A defect in the title from Rina caused a diminution in the value of Plantagenet's lien, thereby creating conflicting interests between the parties.

Respondent admitted that she did not disclose to Plantagenet, Kosch or Rina the potential for conflicts of interest. Likewise, she did not seek written waivers of conflict from any of the persons or entities involved in the matters. Respondent admitted that the simultaneous representations of Plantagenet, Kosch, Rina "and possibly others" with conflicting interests violated RPC 1.7(a). She also stipulated that her failure to obtain written waivers of conflict from her clients and their entities violated RPC 1.7(b).

Finally, respondent conceded that her failure to set forth in writing the rate or basis of the legal fee for Plantagenet's representation, violated RPC 1.5(b).

In mitigation, the Board considered that respondent has no prior discipline, since her 1994 admission to the bar.
