The Disciplinary Review Board reviewed the motion for discipline by consent (reprimand) filed by the Office of Attorney Ethics (OAE) in the above matter. Following a review of the motion, the Board determined to grant the motion.

In the Board's view, a reprimand is the appropriate measure of discipline for respondent's violation of <u>RPC</u> 8.4(d) (conduct prejudicial to the administration of justice). Specifically, respondent's stipulated sexual contact with his client, K.W., lacked professionalism and violated her "right to feel safe during consultations with her attorney." <u>See</u>, <u>e.g.</u>, <u>In the Matter of Terry G. Tucker</u>, DRB 02-397 (May 17, 2002) (slip op. at 4).
