
And good cause appearing;



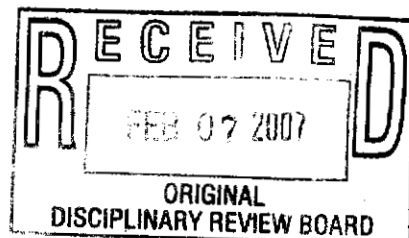
