LETTER OF ADMONITION

Dear Mr. Sanderson:

The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, in 1998 you were retained by Angela Doyle to represent her in connection with a DWI charge. During the course of your representation, you made discourteous and disrespectful communications to the municipal court judge and to the municipal court administrator. Your conduct was unethical and in violation of *RPC* 3.2.

In imposing only an admonition, the Board considered your decades of service as a member of the bar and the fact that your conduct was motivated by zeal in representing your client. The Board determined to forewarn you, however, that any similar misconduct will result in more severe discipline.

Your conduct adversely reflected not only upon you as an attorney, but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. R. 1:20-15(f)(4).
