Dear Mr. Olitsky:

The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, on or about September 18, 1990, at a time when you were a partner in the law firm of Abramowitz & Olitsky, you were retained to pursue a name-change application in behalf of Laverne Powell's minor child. You quoted a fee of \$475 to Ms. Powell, who advanced the sum of \$250 to the firm of Abramowitz & Olitzky. Ms. Powell was not presented with a retainer agreement for her signature. Thereafter, no work whatsoever was performed on the file, although Ms. Powell provided to you all the necessary information. Your conduct in not preparing and executing a fee retainer agreement violated <u>RPC</u> 1.5(b) inasmuch as you had not regularly represented Ms. Powell. In addition, you conduct in not informing Ms. Powell, upon non-payment of the \$475 fee, that the firm would not initiate the matter unless full payment was made violated <u>RPC</u> 1.4.

Your conduct adversely reflected not only upon you as an attorney but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. <u>R</u>.1:20-15(f)(4).

A permanent record of this occurrence has been filed with the Clerk of the Supreme Court and the Board's office. Should you become the subject of any further discipline, it will be taken into consideration.

The Board has also directed that the costs of the disciplinary proceedings be assessed against you. An affidavit of costs will be forwarded under separate cover.
