LETTER OF ADMONITION

Dear Mr. Mayerovic:

The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, an Office of Attorney Ethics ("OAE") random audit, conducted in March 2008, revealed a number of recordkeeping deficiencies in connection with your trust account records. Some of the problems had also been identified in a 1990 OAE audit. Your conduct was unethical and a violation of RPC 1.15(d).

In imposing only an admonition, the Board considered your unblemished ethics history and your cooperation with the OAE.

Your conduct has adversely reflected not only upon you as an attorney but also upon all members of the bar. Accordingly,

the Board has directed the issuance of this admonition to you. R. 1:20-15(f)(4).

The Board has also directed that the costs of the disciplinary proceedings be assessed against you. An invoice of costs will be forwarded under separate cover.
