Dear Mr. Marum:

The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, you were retained by Louise Smith, the mother of Kalvin Smith, to represent him in an action for injuries sustained in an accident on October 11, 1983. After the case was settled in January 1988, the proceeds of \$12,500 were deposited into court. Because Kalvin was allegedly incompetent, the settlement proceeds could not be disbursed before the appointment of a legal guardian. You undertook to have Mrs. Smith appointed as legal guardian. Despite your obligation to represent your client's interests diligently, after July 1988 you did not take adequate steps to have Mrs. Smith appointed as Kalvin's guardian. In addition, starting in 1990, you failed to comply with her numerous requests for information about the matter. Your conduct was unethical and violative of RPC 1.3 and RPC 1.4(a).

In imposing only an admonition, the Board considered your prompt admission of wrongdoing and contrition.

Your conduct adversely reflected not only upon you as an attorney but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you.  $\underline{R}$ . 1:20-15(f)(4).

A permanent record of this occurrence has been filed with the Clerk of the Supreme Court and the Board's office. Should you become the subject of any further discipline, it will be taken into consideration.

The Board has also directed that the cost of the disciplinary proceedings be assessed against you. An affidavit of costs will be forwarded under separate cover.
