The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, you failed to comply with the district ethics committee investigator's requests for information about the grievances filed against you. Your conduct was unethical and violative of RPC 8.1 (b). The Board dismissed the remainder of the charges made against you for lack of clear and convincing evidence.


Your conduct adversely reflected not only upon you as an attorney but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. R. 1:20-15 (f) (4).
