The Disciplinary Review Board (Board) has received your respective letters dated June 16 and June 17, 2011, submitted in connection with the above-captioned default matter, which was calendared for the June 16, 2011 session of the Board.

In Mr. Carlin's response to Mr. Gronikowski's letter setting out the Office of Attorney Ethic's (OAE) position on the appropriate quantum of discipline, he requests the opportunity to respond to the pending charges. The Board has determined to consider this request as a motion to vacate the default and has further determined to grant the motion.
