LETTER OF ADMONITION

Dear Mr. Smith:

The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Following a review of the record, supplemented by oral argument, the Board determined to impose an admonition.

Specifically, in 2009, you represented Lee Bradford in a personal injury action against the City of Asbury Park, which was dismissed on summary judgment. Although you filed an appeal, the Appellate Division granted the defendants' motion to dismiss. You failed to notify Bradford of both the motion and of its disposition, a violation of RPC 1.4(b).

Your conduct adversely reflected not only upon you as an attorney, but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. R. 1:20-15(f)(4).
