The Disciplinary Review Board, with the approval of the Supreme Court, has concluded that an admonition is the appropriate discipline for your misconduct in the above matter. Specifically, during a January 26, 1998 random audit of your attorney accounts, numerous recordkeeping deficiencies were found, in violation of *RPC 1.15(d)*.


Your conduct adversely reflected not only upon you as an attorney, but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. *R.1:20-15(f)(4)*.

A permanent record of this occurrence has been filed with the Clerk of the Supreme Court and the Board's office. Should you become the subject of any further discipline, it will be taken into consideration.
