The Disciplinary Review Board has reviewed your conduct in the above matter and has concluded that it was improper. Specifically, on or about September 18, 2000, you filed a complaint for divorce on behalf of Lori Perry. Although you knew that Ms. Perry had been a resident of Burlington County when the cause of action arose and for more than one year next preceding the commencement of the action, you nevertheless changed the complaint to allege residency in Essex County. Your conduct was unethical and in violation of RPC 3.3(a)(1).


Your conduct adversely reflected not only upon you as an attorney, but also upon all members of the bar. Accordingly, the Board has directed the issuance of this admonition to you. R. 1:20-15(f)(4).
