SEITZ, pursuant Rule 1:21-6, restrained from disbursement except application to this Court, for good cause shown, by Order of this Court of June 22, 1992, shall be transferred by the financial institution to the Clerk of the Superior Court who is directed to deposit the funds in the Superior Court Trust Fund, pending further Order of this Court; and it is further

ORDERED that respondent comply with Administrative Guideline No. 23 of the Office of Attorney Ethics dealing with disbarred attorneys.
